We have signed a master affiliation agreement to partner with UMass-Chan Medical School, to establish a regional medical school, to be named UMass Chan-Lahey. This is tremendously exciting. UMass Chan and Lahey bring together complementary strengths in medical education, along with a shared vision and forward thinking commitment on how best to educate the next generation of caregivers in service of the Commonwealth of Massachusetts. This new relationship will feature a "Lahey track," which will be dedicated to teaching interdisciplinary team care, leadership, quality and
